On August 15th, 1916, Henry made his way to the recruiting station at the CLB Armoury on Harvey Road, St. John's and signed up for service in the Royal Newfoundland Regiment.


His enlistment documentations provide the following about Henry:

- He gave his age as 18 (6 months) but according to his mother, she contended he was just 17
- Was a fisherman by trade
- Stood 5' 8 ½' tall
- Weighed 154 lbs
- Was single

- Was Church of England
- Enlisted for "the duration of the war or until discharged."

Henry's Service Record contains the following hand-written notations:

- 1. 15 Aug 1916: Enlisted
- 2. 23 Mar 1916: Embarked St. John's SS Sicilian

- 3. 09 Jul 1916: Embarked for BEF (British Expeditionary Force) from Southampton
- 4. 10 Jul 1916: Disembarked Rouen, France
- 5. 21 Jul 1916: Joined Battalion
- 6. 12 Aug 1916: Killed in Action (Belgium) just east of Ypres in a shell attack.

Henry had served just six months (178 days) in the Regiment when he was killed in action.

The original resting place for Henry was at the Menin Road North Military Cemetery but due intense fighting and shelling in the area that decimated the cemetery; those buried there were moved to the Menin Road South Cemetery with the names of all buried there on a Memorial Cypress.

Henry was entitled to two medals:

- The British War Medal
- The British Victory Medal

Killed in Action

Again have the ravages of the great war been brought into close touch with the hearts our peaceful community. Again a family circle has been broken, and another loved one, who went forth in the pride of his strength and young manhood to uphold his nation's honor, now sleeps in a British soldier's grave until the final roll is called.

Thus has the name of another son of Bay Roberts been added to the immortal roll of bonor, and another brave son of Newfoundland has laid down his young life for the cause of right and freedom.

Private Harry Brown, was a son of William Henry and Emma Brown, of the Old Barracks Road, and was but 19 years of age, at the time of his death.

He enlisted in the Newfoundland Regiment last apring, went to England in July, and was drafted to France, from Ayr, only a short time ago, to help fill the depleted tanks of the Regiment after its heavy losses of the lat July.

He was one of a family of six children, and leaves to mourn his loss, besides a father and mother, two sisters and three brothers. One of his brothers, Samuel, is a Naval Reservist, on board H. M. S. Duchess of Devonshire, doing duty in the North Sea.

The deceased was a member of the Salvation Army, and had attended the day school of that denomination.

The sympathy of the entire community, in which the Guardian joins, will go out to the bereaved family in large measure, to cheer and sustain them in their hour of trial.
